FORMER AGENDA ITEMS, FOLLOW UP - COMMISSIONERS

Water shares - Commissioner Bingham

Commissioner Bingham stated in a prior Commission meeting the Commissioners talked about leasing or selling the county owned water shares on their own. He stated there are some regulations such as having to file a transfer in order for shares to be leased or sold. He explained the deadline to do so would be tomorrow.

Commissioner Summers explained there are people who are willing to either buy or lease the shares.

Deputy County Attorney Anne Hansen stated in the last meeting they misspoke as shares are considered personal property not real property so the surplus property rules are different. She also said an option would be to have the shares go to the Great Salt Lake. She said with the deadline they should look at what is the best use for the shares next year.

EMERGENCY MANAGEMENT ISSUES

Bus Rollover on I-84 - Kevin Lloyd

Kevin Lloyd, Fire Marshal, explained it has been a challenging two months as they had a mass casualty roll over on I-84. There were 34 people on the bus and 27 were transported to hospitals. He reported that several agencies assisted. He commended the first responders and incident commander. He thanked everyone for their help.

COMMISSIONERS

Commission Chairman Appointment and Commissioner Assignments-Commissioners

Commissioner Summers stated it is necessary to appoint a Chairman for 2023.

MOTION: Commissioner Perry made a motion to appoint Commissioner Summers as the Commission Chairman for 2023. The motion was seconded by Commissioner Bingham and

unanimously carried on a roll call vote of Chairman Summers voting Yea, Commissioner Bingham voting Yea, and Commissioner Perry voting Yea.

Commissioner Perry read the assignments for each Commissioner for 2023.

Commissioner Bingham questioned whether the fairgrounds supervision should be changed as Chairman Summers is a relative of the manager.

The Commissioners discussed that if any personnel issues were to arise there would be more than one Commissioner involved.

MOTION: Commissioner Bingham made a motion to approve the recommended Commission assignments. The motion was seconded by Commissioner Perry and unanimously carried on a roll call vote of Chairman Summers voting Yea, Commissioner Bingham voting Yea, and Commissioner Perry voting Yea.

Reschedule January 18, 2023 Commission Meeting-Commissioners

Chairman Summers explained there is a conflict for the January 18, 2023 Commission meeting. He stated the County Day on the Hill is that day and will involve the Commissioners and other Elected Officials. He recommended the meeting be rescheduled to January 25, 2023.

Bear River Mental Health Contract #23-01 for 2023-2033-Commissioners

Chairman Summers explained Contract #23-01 is with Bear River Mental Health. It is a renewal of a prior contract and the only differences are that it has been changed from a five year contract to a ten year contract and an increase to the percentage.

CONTRACT FOR MENTAL HEALTH SERVICES

This Contract is made and entered into by and between BOX ELDER COUNTY, a body politic, which shall be called the "COUNTY" in this Contract and BEAR RIVER MENTAL HEALTH SERVICES, INC., a Utah non-profit corporation, which shall be called the "CENTER" in this Contract.

This Contract is made and entered into by and between the parties based upon the following representations and recitals:

- A. The COUNTY has a commitment to provide comprehensive community mental health services to its citizens as required by law; by the policies, standards, and regulations established by the Office of Substance Use and Mental Health; and by the provisions of funding contracts between the COUNTY and the Office of Substance Use and Mental Health and other funding agencies.
- B. The **CENTER** is able to provide comprehensive community mental health services for and on behalf of the **COUNTY**.
- C. The COUNTY has joined with Cache County and Rich County to create a joint administrative agency known as the "District 1 Mental Health Authority." The purpose of the Authority is to assist each of the participating counties in qualifying for, obtaining, administering, and implementing funds from state and federal sources for the provision of mental health services.
- D. The **COUNTY** has determined, in accordance with the Box Elder County Fiscal Procedures
 Ordinance and the Utah Procurement Code, that there is only one source for the required
 comprehensive mental health services. That source is the **CENTER**.

NOW THEREFORE, in consideration of the mutual terms and conditions contained herein, the parties hereto do hereby agree as follows:

1. CENTER Services

The **CENTER** shall:

- A. Provide or arrange for comprehensive mental health services for the citizens of Box Elder County as mandated by state law and specified in current state and other applicable policy, bulletins, rules, regulations, and contracts as funding allows.

 Assist the COUNTY in the preparation and submission to the Office of Substance Use and Mental Health the Area Plan for Mental Health service delivery. The CENTER shall plan for services described in the annual Area Plan. These services will include the following as defined in Utah Code and described in the Area Plan:
 - (1) Inpatient Care
 - (2) Residential Care
 - (3) Outpatient
 - (4) 24-hour Crisis Care
 - (5) Psychotropic Medication Management.
 - (6) Psychosocial Rehabilitation
 - (7) Case Management
 - (8) Community Support
 - (9) Consultation and Education
 - (10) Forensic Services
- B. Establish and maintain, either directly or by contract, programs licensed under Title
 62A, Chapter 2, Utah Code Annotated, 1953 as amended.
- C. Provide or arrange for civil commitment examinations as well as provide for appropriate compensation of designated examiners.
- D. Develop and implement the terms of any funding contracts between the COUNTY or the District 1 Mental Health Authority and the Office of Substance Use and Mental Health or Utah Department of Health & Human Services.

2. Examination and Audit of Records

- A. The CENTER shall allow the COUNTY, through the COUNTY Auditor or other agent, to examine and audit the financial records of the CENTER as may be requested from time to time by either the COUNTY or the District 1 Mental Health Authority.
- B. Each member of the Local Mental Health Authority shall annually certify that he has received and reviewed the independent audit and has participated in a formal interview with the provider's executive officers.

3. Compensation or Reimbursement

- A. The **COUNTY** will pay compensation or reimburse the **CENTER** for services provided as described in and contemplated by Paragraph 1 above as follows:
 - \$147,400. for services provided by the CENTER as described in Subparagraph
 A.

4. Term

The term of this Contract shall be for ten years from January 1, 2023 through December 31, 2033. The amount for each subsequent year of this Contract will be determined annually by an addendum to this Contract.

5. Public Funds

A. "Public funds" means federal monies received from the Utah Department of Health & Human Services, and state monies appropriated by the Legislature to the Utah Department of Health & Human Services, a county governing body, or a local mental health authority for the purposes of providing mental health programs or services. "Public funds" includes those federal and state monies that have been transferred by this Mental Health Authority to the CENTER under this Contract to

provide comprehensive mental health programs or services for this Mental Health Authority. Those monies maintain the nature of "public funds" while in the possession of the **CENTER** to provide comprehensive mental health programs or services for this Mental Health Authority.

- B. The Contract requires that the **CENTER** utilize public funds in accordance with federal and state law, the rules and policies of the Utah Department of Health & Human Services, and the provisions of the Contract between the Local Mental Health Authority and the Utah Department of Health & Human Services. The Contract provider assures that:
 - (1) None of its employees will violate any federal or state criminal law relative to use or misuse of public funds;
 - (2) Knowingly violate any rule or policy of the Utah Department of Health & Human Services or any provision of Contract between the Local Mental Health Authority and the Utah Department of Health & Human Services.
 - (3) Knowingly keep any false account or make any false entry or erasure in any account of or relating to any public funds.
 - (4) Fraudulently alter, falsify, conceal, destroy, or obliterate any account of or relating to public funds.
 - (5) Fail to insure competent oversight for lawful disbursement of public funds.
 - (6) Appropriate public funds for an unlawful use or for use that is not in compliance with Contract provisions; or
 - (7) Knowingly or intentionally use public funds unlawfully or in violation of a governmental contract provision or in violation of state policy.

Nothing in this Section limits or prohibits the **CENTER** as exempt under Section 501(c)

(3) Internal Revenue Code from using public funds for any business purpose or in any financial arrangement that is otherwise lawful for the **CENTER**.

6. Reports

The CENTER shall provide such periodic or other reports as the COUNTY may from time-to-time request regarding the provision of services, the mental health funding and Area Plan, and any other relevant matters.

7. Indemnification

The CENTER agrees to defend, hold harmless and indemnify Box Elder County, its officers, and employees from and against any loses, damages, injuries, liabilities, suits, clams and proceedings arising out of the performance of this Contract or which are caused in whole or in part by the subcontractor's acts, failure to act, or negligence of the subcontractor's officers, agents, volunteers or employees except where the claim arises out of the sole negligence of Box Elder County. The CENTER agrees to include Box Elder County, its officials, officers, and employees as additional insured on insurance policies as approved by Box Elder County.

8. Amendments

This Contract may be amended from time to time by the parties upon their mutual consent; provided, however, that such amendments shall be written from and executed by both parties.

8. Default

This Contract and the obligations specified herein shall be terminated upon the default of either party to this contract providing that the default is not corrected within one hundred eighty (180) days of written notice of such default.
